SECTION 4: First-Aid Measures

4.1. Description of first aid measures

Immediately remove contaminated clothing. If the patient is likely to become unconscious, place and transport in stable sideways position (recovery position). First aid personnel should pay attention to their own safety.

Developmental toxicity was observed after oral ingestion of high doses in studies with rats and mice, but this effect was not seen in a study with rabbits. Mechanistic studies show that the rabbit is the

relevant species for the classification for human health. As such, and since ethylene glycol is not a developmental toxicant in the rabbit, no classification is warranted.
